Central Bank of Iceland enters into a long-term service agreement with SkySparc

Stockholm, 20 April 2021 – SkySparc, an independent solutions provider, has entered into a multi-year partnership agreement with the Central Bank of Iceland covering use of outsourced support services and OmniFi, SkySparc's proprietary data integration and workflow automation solution.
